About the Fund

The UC Berkeley Chancellor's Community Partnership Fund was created in 2005 by an agreement between the City of Berkeley and the University of California, Berkeley. The agreement provides for the university to make annual allocations to the Fund through the year 2020.

The Fund awards grants for community-based projects that bring together the ideas, energy, and resources of UC Berkeley and the community to enhance the quality of life for Berkeley residents.

The Fund awards grants for projects in two categories:

Neighborhood Improvement Projects that enhance the physical environment of Berkeley neighborhoods or facilities that serve the community.

Community Support and Service Projects that enhance the economic, social, and cultural wellbeing of Berkeley residents.

An advisory board of community leaders and representatives of the campus and the City of Berkeley establish grant criteria and priorities for the Fund, review proposals, and recommend grant awards to Chancellor Birgeneau.

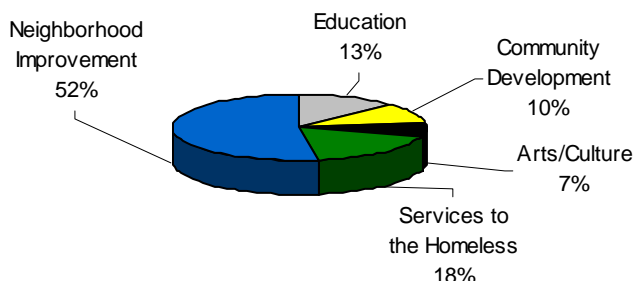

2006-2007 Program Highlights

The first Chancellor's Community Partnership Fund grants were awarded for the 2006-2007 academic year. Forty-five grant proposals were received and the following 15 projects were funded.

Community Service and Support Projects

Berkeley High Student Court provides a positive alternative to suspension for Berkeley High School students facing disciplinary action. Berkeley Law students trained 35 student advocates. Of the 47 respondents referred to the court, 44 were not suspended and completed alternative consequence plans. (\$10,000)

Cal in the Classroom Partnership works to enhance the science education of Berkeley elementary school students. Fifty-two UC Berkeley graduate students in the sciences made 136 classroom presentations using 23 unique lessons for 3,000 Berkeley students. (\$10,000)

Dorothy Day House Homeless Breakfast & Shelter Project supports a breakfast program and emergency storm shelter for homeless people. The grant supported 2,600 breakfasts for over 450 unduplicated individuals. On average, 20 UC Berkeley volunteers (one-third of all the volunteers) participated in the program weekly. (\$5,000)

Jazz Masters Workshop Series offered a hands-on workshop for young Berkeley musicians taught by a professional artist scheduled to perform in Cal Performances' 2006-07 season. (\$5,000)

Poetry Flash Community Poetry Series expands and improves accessibility to nationally recognized poets through public poetry readings and a Watershed Environmental Poetry Festival. Ninety-three poets read their work to about 3,000 attendees at two poetry festivals and 39 readings. The grant enabled this 24-year-old tradition to continue after the closure of Cody's Books on Telegraph Avenue. (\$8,000)

2006-2007 Program Highlights

WriterCoach Connection Literacy provides individual, trained writing coaches to work with 8th grade students at Longfellow Middle School. The grant from the Fund enabled expansion of the program to 7th grade students. Sixty-three coaches, including 36 new UC Berkeley volunteers, worked with five teachers and 273 students, conducting 2,229 writing conferences. (\$5,000)

Youth Emergency Assistance Hostel Volunteer Coordination

Expansion project hired a volunteer coordinator to recruit and train UC Berkeley students as peer mentors to homeless youth and to expand community volunteer participation. Over 45 UC Berkeley students provided 420 hours of work serving and developing personal connections with 105 homeless youth. (\$21,260)

Neighborhood Improvement Projects

Berkeley Orphaned Monuments Project is the first phase of a long-term plan to conserve, preserve, and restore Berkeley's public architectural features by inventorying, mapping, and documenting such historic features as walls, stone pillars, steps, and walks. UC Berkeley students surveyed the following neighborhoods: Oceanview, Northside, Southside, Dwight/Hillside, and the Claremont, and the data has been transferred to the university's Geographic Information Science Center. (\$15,000)

Greening Berkeley Hands-on is a collaboration of local environmental groups that marshals volunteers and provides materials to enable citizen groups to restore and improve people-friendly, biodiverse green spaces throughout Berkeley. Alongside their community partners, hundreds of UC Berkeley students contributed close to 1,500 hours of work on projects around the city. (\$19,231)

Kingman Hall Creekside Amphitheater Restoration Project is the first phase of planning and restoring this community amphitheatre and creekside area. A common vision for the community gathering space was achieved, and other activities included monthly cleanup and vegetation management parties, substantial trimming of overgrown branches, replanting of empty hillside with native plants, and replacement of the amphitheatre's decaying wood seating with stone seating for 60 people. (\$15,000)

(\$11,000)

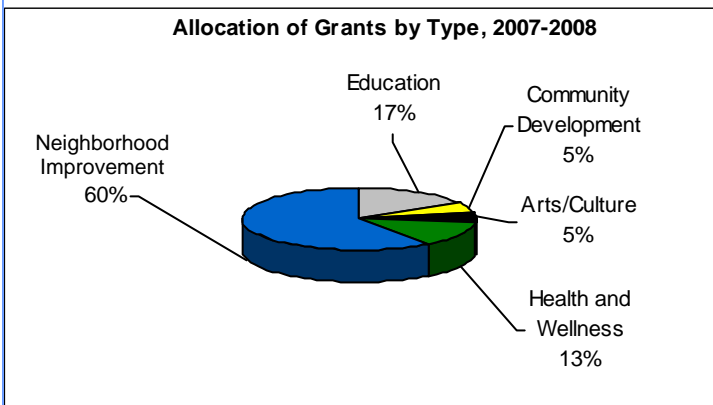

2007-2008 Program Highlights

In 2007, 50 applications were received and the following projects were funded:



Community Service and Support Projects

Berkeley High Student Court provides a positive alternative to suspension for students facing disciplinary action. Berkeley Law students trained 21 student advocates. Thirty-six students were not suspended and have completed or are working on their consequence plans. (\$7,500)

Berkeley High School Youth Organizing Team engages high school youth in multicultural, multiracial leadership programs, advocating for youth-led school and community change. Three student leaders and 32 core team members conducted activities focusing on ethnic studies, student rights, and the achievement gap, and helped introduce mechanisms to educate students about college A-G requirements. (\$5,000)

Evaluation of the Berkeley Schools Mental Health Program measured the program's success in improving the academic performance, health, and social/emotional wellbeing of students and in increasing the knowledge and skills of school staff and service providers. Three School of Social Welfare graduate students designed a comprehensive evaluation plan. The evaluation demonstrated that significant progress has been made in implementing the Universal Learning Support System in the Berkeley schools. (\$10,000)

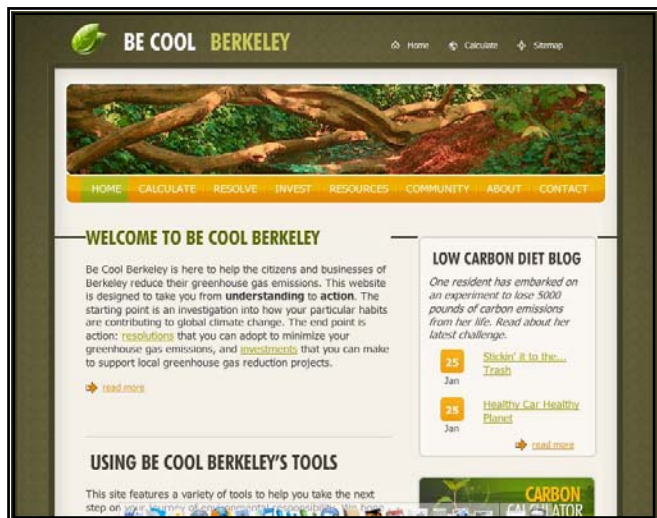
